- ICCVAM is looking into approaches to develop metrics




EU Requirements

- Council Directive 86/609/EEC
 - Laws, regulations, and administrative provisions regarding protection of animals used for experimental and other scientific purposes
- Article 13: Collect statistical information on the use of animals in experiments for scientific purposes in the EU (<u>any</u> live non-human vertebrate)
- Article 26: Report data every 3 years




UK Requirements

- Animals (Scientific Procedures) Act 1986
 - Applies to any living vertebrates other than humans
- Section 21(7): "The Secretary of State shall in each year publish and lay before Parliament such information as he considers appropriate with respect to the use of protected animals in the previous year for experimental or other scientific purposes."

U.S. Animal Welfare Act

- United States Code (USC)
 Title 7 Agriculture
 Chapter 54 Transportation, Sale, and Handling of Certain Animals
 Sections 2131 2159
- Covered species includes: Dog, cat, nonhuman primate, guinea pig, hamster, rabbit, or any other warm-blooded animal
- Covered species does not include: Birds, rats of the genus Rattus and mice of the genus Mus, bred for use in research
- Based on EU and UK numbers, likely missing >70% of the animals used in research and testing



Challenges in Developing U.S. 3Rs Metrics....Here a few

Developing metrics & interpreting metrics

- Different regulatory structures among U.S. agencies
 - E.g., degree to which submitted data can be made publically available
 - Testing performed under regulatory schedules vary
- R&D testing done within companies (i.e., not submitted to regulatory agencies) which may not be submitted
- Testing done in other countries and submitted to U.S. agencies
- Outdated filing/data submission systems
- Data requirements in other countries: Studies not required in the U.S. but still required other places
