

#### **Five Year Plan**

Section 249(e) Not later than December 31, 2020, the Secretary shall submit to such Committees a plan under which the Secretary will eliminate or reduce the research conducted using canines, felines, or non-human primates by not later than five years after the date of the enactment of this Act. *Public Law 116-94, page 274* 







Validation of Patient-Specific, iPSC-based In Vitro Liver System.


In vitro models of toxoplasmosis for preclinical drug development.

#### **Programmatic Approaches to Alternative Methods**

Expanded opportunities to utilize Alternative Methods through carefully constructed Memorandums of Understanding with Affiliates.

Significantly expanded monetary incentives to develop Alternative Methods for current multi-species animal models.

Developed review criteria to include the rationale for the model selection and validation.


Review and supplement education programs centered on Alternative Methods.

Effectiveness of strategies will be evaluated based on the numbers of applications funded in each area and the success of each proposal in generating and validating an alternative.

Retained the services of an independent research organization to analyze and evaluate the progress in decreasing animal use as provided by Law. Incorporates analysis of actively promoting Alternative Methods.
